THE HERTZ FELLOWSHIP PROGRAM INVESTS IN THE FUTURE OF SCIENTIFIC EXCELLENCE AND INNOVATION BY SELECTING RECIPIENTS OF AND FUNDING THE MOST PRESTIGIOUS 5-YEAR PHD FELLOWSHIP IN STEM IN THE U.S. FUNDING FELLOWS' TUITION AND STIPEND IS FOUNDATION'S CORE MISSION AND COMPRISES THE LARGEST ANNUAL EXPENSE. IN FY '19, THE TUITION AND STIPEND PACKAGES TOTALED \$1.4M FOR 62 STUDENTS, 32% OF TOTAL EXPENSE.
