IN FISCAL YEAR 2020, COMPENSATION PACKAGES TOTALED \$1.8M FOR 72 STUDENTS, 37 PERCENT OF TOTAL EXPENSE. THE FOUNDATION'S GOAL IS TO RAISE ENOUGH SUPPORT TO FUND ALL WORTHY CANDIDATES EACH YEAR; HOWEVER, CURRENT RESOURCES ALLOW FOR ONLY ONE-THIRD OF ALL WORTHY CANDIDATES TO RECEIVE A FELLOWSHIP. TO ACHIEVE THIS GOAL, THE HERTZ FOUNDATION BOARD OF DIRECTORS AUTHORIZED A SIGNIFICANT BUDGET INCREASE TO BUILD A MORE AGGRESSIVE AND SUCCESSFUL NATIONAL FUNDRAISING AND PUBLIC RELATIONS EFFORT. SOME DONORS RESTRICTED THEIR GIFTS TO SUPPORT BUILDING FUNDRAISING CAPACITY. TANGIBLE RESULTS CAME QUICKLY, WITH FISCAL YEARS 2016-2019 PRODUCING RECORD FUNDRAISING CASH RESULTS FROM \$2.3M IN (CONTINUED AT SCHEDULE O)
